No.5/6/2002-FD(TAX)Pt-1: Whereas draft amendment of Schedule-1 of the Manipur Value Added Tax Act, 2004 (Manipur Act No. 9 of 2005) was published, as required under Section 22 of the Manipur Value Added Tax Act, 2004 under Govt. Notification No.5/6/2002-FD(TAX)Pt-1 dated 12/8/2011 in the Manipur Gazetted Extraordinary No. 510 dated 2/11/2011 for exclusion of 'Coconut oil' from the category of items as prescribed in Entry No. 5. 'Edible oil and oil cakes' and Entry No. 13 'Vegetable oil including gingili and bran oil' in Schedule-1 inviting objection/suggestion from individuals/parties likely to be affected thereby within 14 days from 19th October, 2011;

Whereas objection/suggestion was received from one proprietor of Stores which as near examined and duly taken into consideration by the government;

Now, therefore, in exercise of powers conferred under Section 22 of the Manipur Value Added Tax Act, 2004, the State Government hereby amends the following entries in the Schedule-1 appended to the Manipur Value Added Tax Act, 2004 as below:

(i) Entry No. 5.

The word 'Edible oil and oil cakes' shall be substituted with the word 'Edible oil excluding Coconut of and oil cakes'.

(ii) Entry No. 13. The word 'Vegetable oil including gingili and bran oil' shall be substituted with the word 'Vegetable oil including gingili & bran oil except coconut oil'.
